POP KIDS YOGA is a classified data controller under the **EU GDPR** (General Data Protection Regulation May 2018). In the following section we will provide our privacy notice dating 06.12.2018. Any changes in the EU directive will be reflected in our privacy notice within the shortest possible time. With our privacy notice we strive to provide concise, transparent and intelligible information about our data collection and processing activities.

- **Who is collecting the data?** The personal information collected on the POP KIDS YOGA 2019 Registration form found on www.popyogakids.com is collected by POP KIDS YOGA Teacher Dora Szent-Ivanyi, freelance Child-, Hatha-, Vinyasa Yoga Instructor. Registration according to the American Yoga Alliance Guidelines 100h Registered Child Yoga School, 200h Registered Yoga School. Registering Institute: WAY Europäische Akademie für Yoga und ganzheitliche Gesundheit / Germany.
- **What data is being collected?** We collect personal data – including personal, contact (digital, physical, telephone) and high level health and behavioral information of children and/or of their parents / legal guardians.
- **What is the legal basis for processing the data?** POP KIDS YOGA teacher Dora Szent-Ivanyi provides educational yoga activity classes for parents / legal guardians and/or their children. In order to ensure a safe and high level yoga practice the information collected in this registration form is crucial both for the legal subject and POP KIDS YOGA teacher Dora Szent-Ivanyi.
- **Will the data be shared with any third parties?** No data will be shared with third parties. All data processing, handling and usage is solely executed by POP KIDS YOGA teacher Dora Szent-Ivanyi.
- **How will the information be used?** The information will be used solely by POP KIDS YOGA teacher Dora Szent-Ivanyi. Relevant information will be used to contact, inform and better understand the data subjects medical condition and behavioral patterns and preferences in order to provide safe and high quality parent / legal guardian and/or child yoga education.
- **How long will the data be stored for?** The personal information provided in this form will be updated on a 6 months basis in the case of a regular attendance. The data will be entirely deleted after 6 months with no further record stored by POP KIDS YOGA teacher Dora Szent-Ivanyi on any computers and physical storage locations.
- **What rights does the data subject have?** All parents / legal guardians and yoga students have the right to refuse completing the information sections in our 2019 Registration form which are not marked with a star. We also provide the right to withdraw the provided Data Processing, Data Handling and Data Usage consent at any point of time.
